PRESIDENT'S REPORT 2023

The five concerts presented in 2023 were each a success, enjoyed by audiences, even if those audience numbers were still a bit low. It seems recovery from the COVID years is still in progress.

The Melbourne Chamber Orchestra under direction from Sophie Rowell presented a very eclectic program ranging from Bach to a jazz inspired piece by Perkinson, a contemporary American composer. A highlight of the program was a lesser known Mozart piece, Adagio and Fugue in C minor, which prompted Sophie to comment "It's hard to believe it's Mozart". This wonderful ensemble has performed every year since the GCMS began.

The next concert presented something quite different, a harp and flute duo featuring Marshall McGuire and Paula Rae. Our audience was charmed by the combination of these two instruments in a relaxed and very entertaining recital. Performing a selection of solo instrumentals, arrangements for flute and harp and pieces written for the combination, Marshall and Paula demonstrated the diverse music suited to this combination.

Flinders Quartet made their second appearance for GCMS proving why they are at the top of the ensemble ladder in Australia. An iconic quartet by Dvořák was coupled with more modern pieces, all illustrating this ensemble's mastery of the form.

Sophie Rowell appeared again in concert number four, along with pianist Timothy Young; both are lecturers at the Australian National Academy of Music. ANAM students presented a mostly modern program including contemporary pieces from Russia and Poland and a more approachable quartet by Janáček. Directed by Sophie and Timothy, ANAM students always present interesting combinations of instruments and works not usually heard.

The year concluded with a recital from eminent pianist Ian Munro, who delighted the committee by asking "what would you like me to play"! Ian gathered our suggestions and presented a very generous program of well known classical and romantic masterpieces. A highlight was his performance of the seldom heard *Valse Nobles et Sentimentales* by Ravel. Equally well known in Australia and overseas, Ian engaged the audience with his relaxing chat while presenting the very epitome of a piano recital.

2023 saw audience number climb a little after COVID but maybe not as much as we wished. Living costs in the second half of the year began to spiral to a point where many people had a second thought when it came to purchasing concert tickets. Add to this, our ageing audience often choose not to drive at night, especially in winter and young people don't appear to bb filling the gaps. We can only hope for a better 2024.

2023 also saw major changes in the GCMS Committee, with the resignation of Anne, Hugh had resigned as President the year before. New recruits were found in Peter, Simon, Will and Rebecca.

The GCMS remains positive and committed to providing Geelong with very high quality chamber music and hopes 2024 will prove to be a great year. Donataions are



TREASURER'S REPORT 2023

The 2023 year was quite a difficult one financially for the Geelong Chamber Music Society. It was possibly the first year in the history of the GCMS in which no grants were received at all. The COGG grants, which have been a regular income source, have changed their criteria for selection and the GCMS no longer seems to fit their requirements. Donations have also dropped from approximately \$2500 in 2021 and 2022 to only about \$1000 in 2023. This gave us an overall drop in income of over \$7000. This has not been offset by a rise in ticket sales, as audience numbers have not really picked up substantially since the COVID drop and have stayed considerably lower than pre-COVID numbers.

Our artist performance fees were lower in 2023 than 2022 by about \$4000, which kept our losses down somewhat. However, the loss for the 2023 year was over \$9000. This is a similar figure to 2022, which was our first year back after the COVID. An annual loss of this magnitude in the long term is not sustainable. Rising costs for advertising, venue hire, insurance etc are also a concern.

During 2023 the GCMS applied for, and was recently awarded, a Robert Salzer grant of \$6000. This has relieved some of the pressure on our finances, meaning no immediate action needs to be taken regarding additional sources of income. If this grant becomes an ongoing annual source of income, pressure for options such as increased ticket prices or donations would be relieved at least in part. The 2024 program is also a very attractive one and will hopefully increase our ticket sales income.
